Contributions of \$5,000 or more to the Orange County Legacy Fund will name the donor or his or her honoree to the list of CAPITAL DONORS. Contributions of this size create endowments named for the specific donor or donor's honoree, and grants made from the endowment are made in their name(s). CAPITAL DONORS' names are listed on a separate plaque in the Foundation office, and a special gift is given to the donor in appreciation of the contribution.

Each donor will be issued a tax receipt for their contribution.
