

The incentive includes students attending trade schools or vocational training.

NON PROFIT Symposium benefits orange county

Representatives of 20 Orange County non-profit organizations gathered together in November to learn and discuss ways and means of working together toward the benefit of Orange County.

The symposium, sponsored by OCCF through SRD funds provided by the Lilly Endowment, featured local instructors as well as guest speakers from United Way of Southern Indiana and the Indiana University School of Philanthropy.

Guest speaker June Miller spoke on the importance of marketing and marketing strategies designed to deliver a non-profit organization's message. She stressed that every non-profit organization has a unique identity and mission, and those should be presented honestly and clearly to the target audience.

Orange County Extension Educator Mary Jo Robinson's presentation covered collaborations. Following an extensive overview of collaborative endeavors, Robinson led an exercise designed to teach participants the importance and the mechanics of successful collaborations.

From the IU School of Philanthropy, Jamie Levy made an extensive presentation on fund development. He offered a wide array of statistics and research findings, which in turn have changed the face of fund-raising throughout the non-profit field. Levy noted that Americans are the most giving people in the world, giving almost nine times more of their income to charity than the second most giving country, Canada. He stated that, even in economic hard times, the American people are touched by the plight of those less fortunate and reach out to help others in need.

Capping off the day was a panel discussion on fund-raising. Featured panelists were Larry Hollan of Orange County Players and Throop Elementary School, Lori Kendall of the BHOC Foundation, and Phil Mininger of Orange County Habitat for Humanity. The three discussed ways in which their organizations procure funding, and fielded questions for the audience regarding fund-raising strategies.

Participants in the symposium included various government agencies, libraries, Hoosier Uplands, United Way, churches, and other non-profit organizations benefitting Orange County and Orange County citizens.


MININGER NAMED 2008 MALE PHILANTHROPIST OF THE YEAR
